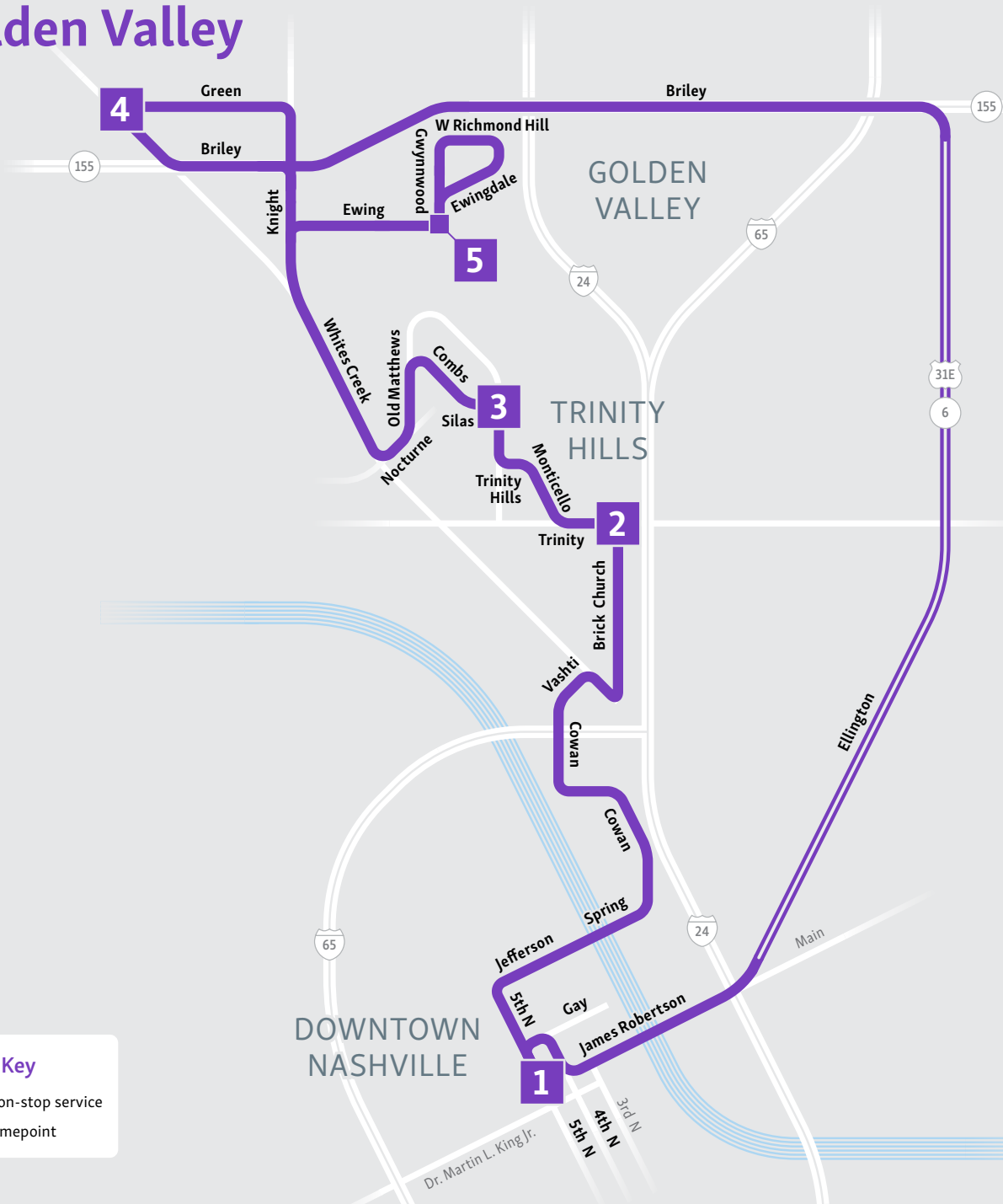

1-Ride Discounted* .....	\$1.00
All-Day Pass .....	\$4.00
7-Day Pass .....	\$20.00
31-Day Pass .....	\$65.00

Children age 4 and younger ride free.

\*Youth, seniors, persons with disabilities, and Medicare cardholders are eligible for discounted fares and passes with proper I.D.
